(2) **Assumption of Risks; Release; Indemnification:** The undersigned acknowledge(s) that Center Activities and/or presence on or about Center premises pose risks of forceful or other harmful contact with equipment, furniture, walls, the floor, the bodies of other persons, and other objects (the "Risks"), including but not limited to risks of suffering contusions, scrapes, burns, sprains, fractures, concussions, bacterial or viral infections, paralysis, and death. The undersigned, in the name and behalf of each of the Child, the undersigned, and the successors and assigns of each of the Child and the undersigned, hereby freely, knowingly, and voluntarily assumes the Risks. Neither Safari Nation LLC nor Kinlaw Leasing LLC, nor any of their respective past, present, or future managers, members, officers, employees, agents, and other representatives, nor the respective successors and assigns of any of the foregoing persons or entities (collectively, the "Safarination Releasees"), shall be liable for any injury to person or property, loss of life or property, or other loss or damage suffered or incurred by the Child or the undersigned as a result of participation in Center Activities, presence on or about the Center premises, or the provision of medical emergency services or transportation thereto or the failure to provide medical emergency services or transportation thereto, all such liability being hereby forever irrevocably waived and released. The undersigned further agrees to indemnify the Safarination Releasees for, and defend them against, all such liability and claims asserting such liability.
